

BYLAW No. 94-4

A BYLAW OF THE
THE RURAL MUNICIPALITY OF EXCEL No. 71
TO PROVIDE FOR ENTERING INTO AN AGREEMENT
RESPECTING FIRE PROTECTION SERVICES

The Council of the Rural Municipality of Excel No. 71, in the Province of Saskatchewan, enacts as follows:

1. The Rural Municipality of Excel No. 71 is hereby authorized to enter the agreement, attached hereto and forming part of this bylaw, and identified as Exhibit "A", with the following municipality:

for the purpose stated within the agreement.

2. The Reeve and the Administrator of the Rural Municipality of Excel No. 71 are hereby authorized to sign and execute the attached agreement identified as Exhibit "A".

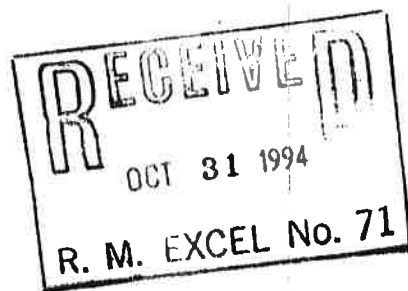
BETWEEN

Willow Bunch & R.M. 42 Fire Association
a committee established by the Town of
Willow Bunch and the Rural Municipality
of Willow Bunch No. 42
(hereinafter referred to as the "Association")

- and -

Rural Municipality of Excel No. 71
a municipal corporation in the Province of Saskatchewan
(hereinafter referred to as the "RM")

1. The Association hereby agrees to provide fire protection services to any part of the RM as may be required from time to time, provided that we have the availability of equipment and manpower.
2. The Association Fire Department shall only respond to a request for assistance when called to do so by the Fire Department or municipal officials.
3. The Association will maintain and operate all equipment required for fire protection. All costs for the equipment will be the responsibility of the Association.
4. The Association will invoice the RM for all fire fighting services.
5. Charges for fire fighting services will be set annually by the Association. The RM will be advised by letter not later than February 15 each year of the rate established by the Association.



6. This agreement shall come into force and effect on the date of signing thereof by all parties to this Agreement.
7. Either party hereto may terminate this agreement upon thirty (30) days written notice to such effect delivered to the other party.
