- 4. Bylaw No. 90-8 is hereby repealed.
- 5. This Bylaw shall come into force and take effect on the date of final passing thereof.

(hereinafter referred to as 'the Association')

AND:

RURAL MUNICIPALITY OF EXCEL NO. 71

RURAL MUNICIPALITY OF LAKE OF THE RIVERS NO. 72

RURAL MUNICIPALITY OF STONEHEDGE NO. 73

(hereinafter referred to as 'the Municipalities')

MEMORANDUM OF AGREEMENT

WHEREAS the Association provides fire fighting services to the Rural Municipality of Lake of The Rivers No. 72 and portions of the Rural Municipalities of No.42, 71 and 73 as assigned by the Provincial Emergency Communications Centre (PECC) (911);

AND WHEREAS the parties wish to clarify the relationship of the Association and the residents of the Municipalities;

- 1. THAT the area of the Municipalities served by the Association as agreed upon by all parties and registered with PECC (911). All individuals residing in the registered area are protected either on a membership basis and/or a fee for service basis.
- 2. THAT if an attendance is made by the Association at premises of a member or non-member, a fee shall be payable to the Association by the member or non-member at a rate specified by the Association from time to time. Members of the Association are those persons who have applied for membership, have been accepted and remain in good standing as members pursuant to the Articles and Bylaw of the Association. All residents of the area served are not necessarily members.
- 3. THAT any existing members in good standing of the Association who are outside the designated area full membership privileges so long as they remain members in good standing. The Association is not obligated to accept members from outside the designated area, but at the sole discretion of the Board of Directors of the Association, such persons may be accepted as members.
- 4. THAT neither the Association, nor any of its members, nor any person assisting the Association of using its equipment shall have any liability to any person for any act done or decision made in good faith with the exception of any claim which

is covered by an insurance policy or policies which the Association or any other party may maintain or be covered by from time to time, including <u>The Workers'</u> Compensation Act.

5. THAT this agreement shall commence on May 1, 2018 and be continuous. The agreement may be terminated by any party to the agreement giving 30 day notice in writing.
