RURAL MUNICIPALITY OF EXCEL NO. 71

BYLAW NO. 14-2023

A BYLAW TO ESTABLISH FEES FOR THE PROVISION OF TAX CERTIFICATES

The Council of the Rural Municipality of Excel No. 71, in the Province of Saskatchewan, enacts as follows:

- 1. This bylaw shall be referred to as the "Tax Certificate Bylaw".
- 2. In this bylaw:
 - a) "Act" shall mean The Municipalities Act;
 - b) "Designated officer" shall mean the Administrator of the municipality or any other person who has been assigned responsibility to issue tax certificates by the municipal council;
 - c) "Municipality" shall mean the Rural Municipality of Excel No. 71.
- 3. Upon receipt of:
 - a) a request for a tax certificate, and
 - b) the required fee of \$10 per property,

the municipality shall provide to the applicant the requested information.

- 4. In addition to the requirements described within subsection 276(1) of the Act, tax certificates issued by the municipality shall contain the following information:
 - a) tax levy for the previous year, if the taxes for the current year have not been levied;
 - b) date of registration and/or the interest number of a tax lien in favour of the municipality;
 - c) the amount required to discharge the tax lien, consisting of arrears and costs; and
 - d) the outstanding amounts which may be added to property taxes pursuant to section 405 of the Act.
- 5. The tax certificate issued by the municipality shall be on Form A, attached hereto and forming a part of this bylaw, which may be amended by the designated officer provided that the amendment does not alter the substance of the form.
- 6. Bylaw No. 3-2022 is hereby repealed.
- 7. This bylaw shall come into force on the day of its final passing.

Read a first time the 14th day of November, 2023.

Read a second time the 14th day of November, 2023.

Read a third time and adopted the 13th day of December, 2023.
