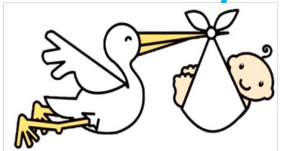

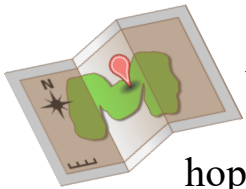
Gopher Poison Rebate
