Assessment Roll is Open For Inspection: March 27, 2026 to April 28, 2026

Updated R.M. Maps: We have new R.M. Maps with the updated assessments and landowners as of October, 2025. Ratepayers receive a free map when taxes are paid in full.

Spring Road Bans: The RM has opted out of the 2026 spring road bans. Please do not haul if the roads are wet and/or soft. Avoid using seasonal roads at this time.

Gopher Poison Rebate: You can receive up to 50% back on registered gopher control products/poison through the SARM Gopher Control Program again for 2026! Contact the RM office for a claim form. Claims must be returned to the office by July 31st.



Weed Inspectors

Lone Star Contracting is the weed inspector for our municipality this year. They will be coming around regularly to inspect all properties. Contact them at (587)-253-1640 for any questions or to report noxious weeds.

Gravel Request Deadline

Requests for private gravel by ratepayers to be used within the R.M. must be submitted to the RM office by **June 15th** each year! Gravel \$15/cu yd; Loading \$1/cu yd; Hauling \$0.50 per cu yd mile.

Building Construction/Demolition/Renovation

The first step when considering a project is to apply to the RM for a Development Permit. This ensures the project complies with the municipal Zoning Bylaw. This confirms IF and WHERE you can build. If that's approved, then apply for a Building Permit. This will confirm HOW you can build it. The municipality has a Building Bylaw in place, as required by the Government of Saskatchewan. If it is a farm building, there is a farm exemption form to be completed to prove you do not need a permit. There is no charge for farm buildings. Viceroy Fire Department Rates

Please take note of the new dispatch rates for the Viceroy Fire Department:

\$600 dispatch fee for first 4 hours

\$100 per hour after that

R.M equipment will attend fires, as requested by the dispatched fire department, to make a fire guard only! They will not stay to patrol the fire, and will not enter yards. This is the responsibility of the fire department dispatched. 911 MUST be called to dispatch any fire department. The invoice will be sent to the landowner/responsible party for the fire, NOT the caller (unless the caller is one of the above).
